MESSAGE FROM THE GENERAL MANAGER

I began working at Breadroot 5 years ago, because I was drawn to its co-operative, community-first ethic. Throughout these years, my knowledge of co-ops has greatly expanded as I've assumed multiple roles at Breadroot, from Front End Clerk to Human Resources, and now as the General Manager. I love helping people and in the broader sense, the community. Needless to say, this is a role that suits me well and I am grateful to get the opportunity to manage such an integral fixture to our local growers, vendors, and customers.

2020 has been a trying year for everyone, but our Co-op especially has been tested as we navigated through some major changes in

management last Fall. When I was asked to come back after a six month break, there was a clear need for someone with my experience. I was initially reluctant, but I saw the potential for a good future for our Co-op, and that potential and love for our community is what brought me back.

The Co-op received a couple big upgrades last summer. A new walk-in cooler and freezer has allowed us to carry more products and have backstock readily available to help keep our shelves full longer. We also installed a new produce cooler to allow for a larger variety of produce.

We have continued seeing increased sales and membership sign ups, this past year. This paved the way for some much needed upgrades that will help us remain competitive. We are in the process of completely revamping our front end registers, making the traffic flow much more efficient, as well as installing a new point-of-sales system and finally adding conveyor belts! This project will be completed within the next couple of months.

Not everything lately has been so optimistic, however. We have seen our highest turnover in the last couple of months, and we are just now beginning to see a return to our usual employment numbers. During these light times, our team has really come together to ensure that all facets of the Co-op are running smoothly, despite our lower than usual staff numbers. We have lost some invaluable employees, and we wish them well on their next endeavors. But in true co-op DIY fashion, we've learned to adapt, as we slowly re-staff our store and get back to 100%.

I'm looking forward to the future of Breadroot, as we recover from a few tumultuous months and get back on track for a really good rest of the year and many more!


